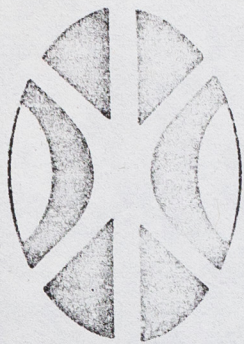

DECLARATION OF MEMBERSHIP ~~delete as appropriate~~

WITH REGARD TO THE REFERENDUM ON BRITAIN'S CONTINUING MEMBERSHIP OF THE COMMON MARKET (E E C), I ..... declare that:-

I HAVE NOT READ THE TREATY OF ROME.  
I HAVE NOT STUDIED THE TONS OF SUPPLEMENTARY PAPER-WORK ON THIS SUBJECT.  
I AM NOT AN EXPERT ON EUROPEAN POLITICAL, SOCIAL, TRADE & ECONOMIC AFFAIRS.

I DO, THROUGH TAXES, PAY THE BRITISH GOVERNMENT AND PARLIAMENT TO MAKE DECISIONS OF NATIONAL IMPORTANCE. I therefore believe that:-

GOVERNMENT CAN CALL ON LEARNED ADVICE AND RESEARCH REGARDLESS OF EXPENSE.  
GOVERNMENT OFFICIALS AND CIVIL SERVANTS HAVE THE TIME AND FACILITIES TO SIFT OUT THE FACTS.  
THE BRITISH PARLIAMENT SHOULD MAINTAIN ITS SOVEREIGNTY.  
THE ELECTED REPRESENTATIVES OF THE BRITISH PEOPLE IN PARLIAMENT SHOULD KEEP THE RESPONSIBILITY FOR THIS DECISION.

AFTER CAREFUL THOUGHT, I consider that:-

IT IS GROSSLY UNFAIR THAT I SHOULD BE ASKED TO MAKE THIS DECISION.

I CANNOT DO JUSTICE WITH A "YES" OR "NO" ANSWER BECAUSE:-

I DO NOT HAVE ACCESS TO ALL THE DOCUMENTATION.  
I DO NOT THINK I WOULD UNDERSTAND IT ANYWAY.  
I DO NOT HAVE TIME TO MAKE SUCH A DETAILED STUDY.

I therefore propose to take the following action:-

ABSTAIN FROM VOTING IN THE FORTHCOMING REFERENDUM.  
MARK BOTH THE "YES" AND THE "NO" ON THE BALLOT PAPER.  
MARK MY BALLOT PAPER "DON'T KNOW".

AND CLAIM THAT THE GOVERNMENT, being bound by the wishes of the majority, WILL BE OBLIGED TO DO ITS OWN JOB if our number is greater than those voting YES or NO.

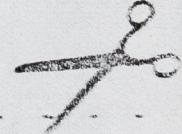

A FOOTNOTE ABOUT 'SPOILED' VOTES. A ballot paper with any mark other than the mark (usually an 'X') authorised at the polling booth, is called 'spoiled'.  
In an election it is not a good thing to spoil your vote. This is not an election - it is a referendum. A referendum is one way a government can try to get rid of a difficult responsibility. If a lot of people ignore the referendum or spoil their votes, the government will be forced to re-assume their responsibility.
