THE OPENING OF CROSBY HALL.

THE VOTE

On Wednesday of next week the Duchess of York will unveil a tablet to commemorate the purchase of Crosby Hall, Chelsea, by the British Federation of University Women, and the completion of the new wing which is being built as a clubhouse and hall of residence for University women, both national and international.

It is now 17 years ago since Crosby Hall, Sir Thomas Mary and Lady Aberdeen. More's old home, was saved from destruction by being moved, stone by stone, from Bishopsgate to its present site on the Chelsea Embankment, only the central part of the original E-shaped building remaining, the wings at either end having been burned down in the Great Fire. The Hall that was left is, as is well known, a wonderful oak-beamed dining-hall, which in Tudor times was used as the general living-room of the family. It was in this room that Erasmus sat and talked with Sir Thomas More and his gifted daughter, Margaret Roper, where Holbein painted, and where all the cleverest men of that day gathered to discuss the new eminently fitting that a Hall of such famous memories should now be occupied by women of University

The new wing, where the residents will have their Hall. The aim of the architect throughout has been to achieve harmony with the original 15th-century building. Even the bricks resemble those of Tudor days, and there are mullioned windows and square chimneystacks in keeping with the same period. On the ground floor will be the common room, the warden's room, and a charming garden room, with big French windows, where members will be able to sit and work practically in the open air. The 43 study bedrooms on the upper floors will be furnished with divan beds that can be used as sofas, and also comfortable writing desks and bookshelves, for the British and foreign women graduates living at the Hall will principally be engaged in some kind of research work. The furnishing of certain rooms is practically assured, for five branches of the Federation-Manchester, London, Birmingham, Yorkshire, and Scotland-have not only each collected the £1,000 necessary to name a room, but are also trying to raise an additional £50 for furnishing. Although only 43 women students can be accommodated with bedrooms at Crosby Hall, any member of the Federation of University Women, whether British or foreign, can use it as a Club, or have meals in the old Hall where so many famous figures of the Renaissance had their banquets in past

During the last four years, when the British Federation first conceived the idea of buying the Hall and turning it into an International Clubhouse for University women, the scheme has met with support from women all over the world, so that £33,000 out of the sum of £50,000 required has already been received.

CANADIAN WOMAN SCHOOL INSPECTOR.

A recent issue of the Glasgow Herald gives an interesting account of Dr. Aletta Marty, the only woman inspector in the public schools of Toronto, where she has been in office since 1919. She inspects one-sixth of all the classes in Toronto, composed of both boys and girls, up to high school entrance, both men and women instructors coming under her supervision. In the Toronto public schools, those institutions supported by the municipality with the aid of Government grants, in which free instruction is given in all classes below high school entrance, fully 80 per cent. of the teachers are women. In the smaller towns and in the rural districts the feminine proportion is very much greater. Although a few of the very small high schools in Ontario are presided over by women principals, Dr. Marty's appointment has represented the most decided advance in women's work in the whole provincial educational system. As teacher of modern languages in

Ottawa Collegiate Institute, the future Inspector had already held one of the coveted posts in the secondary schools, while she was the only woman who had written or compiled a test work for use in the high schools of the province. The importance of the Toronto appointment was recognised by the conferring upon Miss Marty of the honorary degree of LL.D. by her Alma Mater, Queen's University, the only other women preiously so honoured by this institution being Queen

Dr. Marty is an enthusiastic worker for the welfare of young women, and was largely instrumental in obtaining a well-equipped Young Women's Christian Association, with an accompanying hostel, in one of the towns in which she has taught, and also the residence for women students at Queen's University, the corner-stone of which she laid three years ago. was also the prime mover in establishing the Canadian Chautauqua.

In her school work she is a great advocate of equal pay for equal qualifications and equal work. She also recommends the downward extension of kindergarten learning then spreading through Europe. It is age below the present minimum of five years, and a more vitalised curriculum.

SWEDISH WOMEN AND THE ELECTIONS.

Apropos of the recent Swedish elections, "Morganbris" has a very interesting article on the first women elected to the Swedish Riksdag, in 1921, and the stand taken by them on the various questions under discussion, concluding with these words: "They spoke calmly, and as having full knowledge of the subjects with which they were dealing, and the Elders of the Riksdag listened to their words with marked interest." This we can well believe, when we take at random an example such as the following: - During a discussion on unemployment, Fru Thüring, we are told, disputed the position taken up by Herr Björnberg, who held forth to the effect that the unemployed should move out of the towns and go out into the country-'out to the flowers and the birds "-pointing out that, as there were no flowers in the country in winter, it might be a little difficult to carry out the programme; and that, moreover, there were no spare dwellings in the country for them to move into. In regard to the elections, we congratulate our Swedish friends on Fröken Kerstin Hesselgren again being elected to the Upper Chamber of the Riksdag.

PARLIAMENT RE-ASSEMBLES.

Both Houses of Parliament re-assembled last Tuesday for the Autumn Sittings. This week the Second Readings of the Expiring Laws (Continuance) Bill, the Police Pensions Bill, and the Lead Paint (Protection against Poisoning) Bill are to be taken in the House of Lords, and we sincerely hope that their Lordships will carry an amendment to the last-named Bill which will prevent the injustice of women being excluded from employment in painting any part of a building with lead paint. Mr. Baldwin, in the House of Commons, gave a long list of Bills which the Government proposed to carry into law before Christmas. The Report stage of the Electricity (Supply) Bill was proceeded with last Tuesday. Among the Departmental Bills to be taken this Session, and which the Government consider are non-controversial, are the Colonial Divorce Jurisdiction Bill, the Mental Deficiency Bill, the Sales of Food and Weights and Measures Bill, the Wild Birds Protection Bill, the Legitimacy Bill, and the Smoke Abatement Bill, and it was stated that it might be necessary to consider the Lords' amendments to the Expiring Laws (Continuance) Bill, the Lead Poisoning Bill, and the Police Pensions Bill. It is not proposed to proceed with the Factories (No. 2) Bill before the Prorogation. There was no mention of Equal Franchise, and every effort must be made to see that a measure granting the vote to women at the same age and on the same terms as men is included in the King's Speech at the opening of Parliament next February. WOMAN MAGISTRATE HOLDS HER OWN.

We are glad that Mrs. Green, J.P., refused to shirk her duty at Colchester Police Court last week, and remained on the Bench after the Mayor had asked the public to retire from the Court while a charge against a soldier was heard in regard to offences against boys. A fellow-magistrate, Mr. E. P. Hutton, asked if the case should not be considered by men, and only by men. When Mrs. Green replied, "No, certainly not," he left the Court as a protest. In our view, his action was entirely wrong. He had no manner of right to suggest that any magistrate-man or woman-should shirk his or her duty, or to shirk his own duty by withdrawing himself from the Court. He should remember that he and all other magistrates, both men and women, have sworn to "do right to all manner of people under the laws and usages of this realm without fear or favour, affection or ill-will." As Mrs. Green herself said: "If a woman undertakes a public duty, she should perform it faithfully, no matter how unpleasant it may be. I am against women magistrates leaving Court when obectionable cases are heard. They are shirkers." In this particular case, boys of twelve were concerned, and Mrs. Green declared: "As a woman magistrate, I have a duty to all young people, and that duty, I think, must be performed, irrespective of what and against whom the charge may be. I have never heard of anyone going to see a charge sheet and then leaving because there is something disagreeable in it." We congratulate Mrs. Green on the stand she made, and also on her spirited defence of that stand. Readers of THE VOTE will remember that in October last year Mrs. Juson Kerr, J.P. (a member of our Executive Committee), decided to remain on the Deal Bench when an elderly man was charged with an indecent assault on a lad of fifteen years, and after two other women magistrates had retired from the Bench in view of the nature of the case. She, too, felt that it was her duty, as a magistrate, to remain. We cordially agreed with her, and stated at the time that such a case was of the gravest concern to women; and we repeat what we then said: "It is not the business of men magistrates, whatever their motives might be, to question what is women's duty in such cases. Women magistrates have taken the same oath that men magistrates have taken, and we expect them to carry out their whole duty without fear or favour."
