Enactments: Employment of Women and Children

- A) An Enactment, further to amend "The Indian Immigration Enactment, 1927". No. 16 of 1933. Dated 17th October, 1933.
- I. (i) This Enactment may be cited as "The Indian Immigration Enactment, 1927, Amendment Enactment, 1933" and shall come into force on the 1st day of November, 1933.
- (ii) This Enactment shall be read and construed as one with "The Indian Immigration Enactment, 1927" hereinafter referred to as "the principal Enactment."
- 2. The principal Enactment is amended by inserting immediately after section 30 new sections numbered 30A, 30B and 30C as follows:—
- "30A. (i) No female labourer of any age and no male labourer who has not attained the age of eighteen years shall be employed in any kind of labour other than domestic service at night.
- (ii) For the purposes of this section "night" means the period between ten o'clock in the evening and five o'clock in the morning.
- 30B. No child who has not attained the age of twelve years shall be employed—
 - (a) in manufactories working with power and employing more than ten persons;
 - (b) in mines quarries and other works for the extraction of minerals from the earth;
 - (c) in the transport of passengers or goods or mails by rail or in the handling of goods at docks, quays or wharves, but excluding transport by hand.
- 30C. Any employer wilfully contravening the provisions of section 30A (i) or 30B shall be deemed to have committed an offence against this Enactment."
- B) An Enactment further to amend "The Labour (Non-Indian) Enactment, 1928". No. 17 of 1933. Dated 17th October 1933.
- I. (i) This Enactment may be cited as "The Labour (Non-Indian) Enactment, 1928, Amendment Enactment, 1933" and shall come into force on the 1st day of November 1933.
