#### Why we should vote to leave the European Union

#### **The Economic Cost**

- The cost of membership is about £19 billion gross every year in contributions to the EU budget.
- Indirect costs on the economy, including the Common Agricultural Policy, the Common Fisheries Policy and over regulation on business, cost yet more billions.
- The total cost on the economy of EU membership is calculated at about **£190 billion** per year.\* That equates to about £7,000 per household.

#### **The Democratic Cost**

- Most of our laws are now made by the European Union not by our own Parliament and Government in Westminster.
- Almost all areas of our domestic policy are now controlled by the EU. The Westminster Parliament has surrendered control down to the level of legislation on hair-dryers, electric kettles and vacuum cleaners.
- EU Directives must become UK law through Acts of Parliament (Parliament has no choice) and EU Regulations automatically become law without Parliament even debating them.
- Any UK citizen can now be extradited (judicially surrendered) to any other EU state without any evidence being presented against them in a British court – and the court has no power to prevent it. Our traditional freedoms are being destroyed.
