







(3) Organizing Secretary's Report on his Lectures in Provinces.

I visited Edinburgh Fabian Society on Thursday Novr. 2nd and lectured to fair audience. A special effort to prevent the Society being overshadowed by the University Society is being made. The latter body is quite flourishing and maintains its special rooms as a club and for lectures. I lectured at Liverpool to a meeting of the local Fabian Society on Monday. The audience was fair. The Society is much encouraged by the results of Municipal elections in which they took considerable part. On Tuesday I lectured to the Liverpool University Society. It is a small and struggling group which suffers from the fact that its members are the able people in the University who are full up with other work.

The Report was adopted

(4) Scheme for a Press Committee. The office was instructed to report on Sharp's proposals.

(5) Shaw-Chesterton Debates. Shaw having written that he would probably not pass a verbatim report of the debate if it were taken it was decided not to incur the expense.

(6) New Society. The Org. Sec. reported he had arranged to open a new Society at Bowmerville on Nov. 24th.

(7) Brighton Fabian Society. The sec: of the Brighton F.S. wrote that the Society would probably close owing to impossibility of finding a Secretary. It was decided that if the closing down became unavoidable ~~unavoidable~~ the Brighton members be asked to join the London Society.

(8) Mr Asquith's statement with regard to the franchise.

This was brought up as a matter of urgency and it was decided to send the following report and recommendations to the Executive Committee.

As a matter of urgency we have considered Mr. Asquith's statement that the Government intends to extend the franchise on what is practically the basis of manhood suffrage. We think that the Executive Committee should take steps to secure the inclusion of Women's Suffrage in the proposed legislation, and for this purpose we recommend that:-

- (a) That the Executive Committee send a deputation to the Parliamentary Labour Party to urge upon them to press for amendments giving the vote to women on the same terms as for men; and, failing that, to move for the inclusion of women and support amendments for the inclusion of women on the widest possible terms.
- (b) That a Conference be held between the Executive Committee and M. Ps. wh are Fabians to discuss ways and means of securing the inclusion of women in the proposed legislation.

(This was taken as an urgent matter)

(3) Reform Bill Agitation. It was decided to ask the standing joint committee of the D.L.P. and the Fabian S.C. to consider the holding of a big demonstration on the promised Reform Bill and to bring forward recommendations.

(4) Provincial and other Societies.

- (a) Letter was received from the Brighton F.S. stating that the Society was about to dissolve and to recommend all its members to join the London F.S. It was agreed that all the members be written to specially inviting them to join.
- (b) The org: sec: reported that he had arranged to open the Society at Downsville on Nov 24th
- (c) that new Societies had been formed at St. Andrew's University and at Montreal, Canada.
- (d) Org: sec: reported that a strong agitation had been started in Hull on the Housing Question based on the Hull Fabian Tract on the subject.

(5) Training of Lecturers Joint Committee. It was decided that the Education Group be invited to appoint two of its members to be co-opted on to the training of lecturers joint committee.

(6) Invitation to take part in the Albert Hall Meeting against the inclusion of domestic servants in the Insurance Bill

(3) New Society. Org: See: reported he had formed a Society at Bourneville with about 20 members.

(4) Suburban and Provincial Lectures.

(a) The organising secretary reported he had given courses at the following places. Owing to the Woolwich by-election for the L.C.C. he had to secure substitutes for several of the lectures at short notice and he arranged with Miss Murphy and Alban Gordon D.Sc. to take lectures at Ilford, Leytonstone and Gravesend. He also submitted lists of courses given and in progress; also courses provisionally arranged.

Southampton F.S. and I.L.P. The lectures were well attended, audiences averaging over 100.

Ilford F.S. The course was held in different halls, opening at the Town Hall with an audience of 150. The other places were not so well attended.

Forest Gate F.S. This Course is not yet completed. It is being held in Canning Town. The audiences have been about 60, including Town Councillors and other local notabilities.

Gravesend I.L.P. A most successful course in an unpromising town. The meetings were well organised with local persons of importance in the chair and Alderman, councillors and local clergy in the audience. Average attendance over 200.

1.- Demonstration in favour of Adult Suffrage.

It was decided to recommend the constituent bodies in co-operation with the Labour Party to hold a Demonstration in the Albert Hall at a date near to the re-assembling of Parliament in 1912 in favour of Adult Suffrage. Instructions were given to approach the Labour Party at once and invite them to co-operate.

2.- Deputation to the Board of Education on School Clinics.

It was decided that the Chairman of the Labour Party be requested to arrange a deputation to the appropriate members of the Government to urge the provision of funds from the exchequer for the medical treatment of children by means of School Clinics. The deputation to be appointed by the I. L. P. ~~at 7.30~~.

3.- Manifesto on Fabian Policy.

Attention was called to an article in the "Labour Leader" of the week ending December 3rd. dealing with a "Manifesto" on Fabian Policy. The Committee decided unanimously to instruct its chairman and secretaries to write to the "Labour Leader" pointing out although the manifesto is signed by one of the members of this Committee which is promoting closer relations between the I.L.P. and the Fabian Society he did not consult his colleagues before issuing the document. And further to protest against the harmful method of publishing private "manifestoes".

On (2) it was decided that no action be taken, as it had been found impossible to arrange the deputation



I attended, as instructed, the above meeting called
by the Manchester University Fabian Society. There were
present, Ellis (Manchester) chairman, Waddington (Manchester)
secretary, Allen (Cambridge), ^{Hinchliffe (before)} Amott (Glasgow), Fenn (Liverpool)
and myself. The London, Birmingham, Edinburgh and St. Andrews
Societies were not represented, but it was reported that they
were in favour of holding a Conference. It was decided
that a Conference of the University Fabian Societies be
held on March 29th and 30th at Manchester. On the question
of the title of the Conference it was proposed that it be
called an "Inter-University Socialist Conference", and
that its object be the formation of a Federation of University
Fabian Societies under the name of "The University Socialist
Federation". I held that the name Fabian should not be departed
from and gave the view of the Organizing & Propaganda
Committee that the business of Fabian Societies was to promote

likely to challenge public attention than if it were described as a Fabian gathering. It was also stated that for the same reason the proposed Federation should be given the title of Socialist although its purpose would be to establish new and strengthen existing University Fabian Societies. It was finally agreed that the Conference be called an "Inter-University Socialist Conference" with the following note appended "(being a Conference of University Fabian Societies)". Liverpool and Glasgow dissented as they were in favour of the name Fabian being adhered to. It was also decided

- that
- (a) ^{three} delegates be invited to the Conference from each University Fabian Society.
 - (b) that each Society be asked to use funds to meet the cost of the Conference.
 - (c) That the Executive Committee be asked to make a grant towards the expenses.
 - (d) that each Society be invited to put forward suggestions with regard to the constitution of the proposed Federation.
 - (e) that Clifford Allen be Chairman of the Conference.

Several other minor points were also settled. After the meeting I invited Clifford Allen to attend as a deputation to the next meeting of the Organizing & Propaganda Committee to explain further the objects of the Conference and the proposed Federation ^{so} that the Committee may be seized of all the facts before it decides to contribute or not towards the expenses of the Conference, and he agreed to come.

The Women's Group is the largest of the Subject Groups, having a membership of 227. It is open to all women members of the Fabian Society. Its work is fully set out in the Annual Report annexed. All the main activities of the Group, especially under the those in connection with the publication of Tracts etc., have been always reported to the Executive Committee and its advice taken or its consent to action requested.

The Education Group.

This Group is open to all members of the Fabian Society. Its main work has been the holding of meetings and discussions on educational Subjects. The cost of its larger meetings held at Cliffford's Inn Hall has been defrayed by the Executive Committee and the Group has always consulted the Executive Committee with regard to its programme. It recently took part in the organization of an important conference on Half-time. The paying membership is at the moment small mainly owing to disorganization arising from change in the secretaryship.

The Local Government Group.

This Group is open to all members of the Fabian Society. Its

P. in London. The membership is now about 100. I have been informed that the rule giving the Committee of the Nursery power to extend the limiting age has been used freely and that persons considerably over 30 have been elected members while others have been rejected. It seems anomalous that a body having a voice in the management of the Society should have the right to decide arbitrarily as to its membership and it is not in order for such a body to elect associates of the Society as members.

REPORT OF MEETINGS of Delegates of the Joint Committee of the I. L. P. and Fabian Society with delegates of the Labour Party and the Parliamentary Labour Party on April 2nd and 9th 1913 at the House of Commons to form Committee for united national propaganda.

1. Present. April 2nd. A.G.Cameron (Labour Party) in chair; J. S. Middleton (Labour Party); Mrs. Webb, W. S. Sanders and H. H. Schloesser (Joint Committee of I.L.P. and F.S.)

April 9th A. Henderson, M.P. in chair, John Hodge, M.P., A.G.Cameron and J.S.Middleton (Labour Party); Philip Snowden, M.P., G. Barnes, M.P., and G. H. Roberts, M.P., (Parliamentary Labour Party); Mrs. Webb, W.S.Sanders, H.H.Schloesser and F. Johnson (Joint Committee of the I.L.P. and F.S.)

2. Constitution of Committee.

It was decided that the proposed Committee should be formed consisting of three representatives from each of the following bodies:-

Labour Party; Parliamentary Labour Party; Parliamentary Committee of the Trade Union Congress (if willing); Independent Labour Party; Fabian Society and Women's Labour League.

Also that Conferences should be held to deal with trade unionism and political action with special reference to the Trade Unions (No.2) Act modifying the Osborne judgment; and other Conferences, if thought desirable, to promote the movement for the nationalization of railways and mines.

The proposals were agreed to and it was decided to make arrangements to hold Conferences as soon as possible on the subject of Trade Unionism and political action, and J. S. Middleton, F. Johnson and W. S. Sanders were appointed as a Sub-Committee to draw up a scheme. Another Sub-Committee consisting of Mrs. Webb, A. G. Cameron, G. Barnes, M.P. W. C. Anderson, J. S. Middleton, F. Johnson, W. S. Sanders and one representative each from the Parliamentary Committee of the Trade Union Congress and the Women's Labour League, was appointed to prepare a plan for an autumn campaign of Conferences and meetings, etc. in connection with the other subjects. Philip Snowden, M.P. was appointed to write a leaflet pointing out the importance of trade unions taking political action.

The memorandum with regard to the scope of the work of the proposed Committee drawn up by the Joint Committee of the I.L.P. and the Fabian Society and endorsed by the Fabian Executive, is considered, amended as follows and adopted for submission to the various bodies concerned:

A Committee of representatives of the Labour Party, Parliamentary Labour Party, I.L.P., Fabian Society, Women's Labour League and the Parliamentary Committee of the Trade Union Congress, with the title of Labour and Socialist Consultative Committee, shall exist for the purpose of providing machinery by which the various sections of the Socialist and Labour movement shall be kept in touch with each other in regard to their propagandist activities.

The Committee, whilst leaving each section complete autonomy over its own propagandist activities, shall, as far as possible prevent overlapping by acquainting each section with the proposed work of the others.

The Committee shall be the medium through which the Labour Party and the propagandist Societies shall be kept in touch with each other in regard to proposals for legislation in such a manner as to co-ordinate as far as possible the work outside and inside Parliament.

The Committee shall consider and submit to its constituent bodies proposals whereby any piece of work undertaken by one section may be rendered more effective by the co-operation of the others.

FABIAN SOCIETY.

Proposed Fabian Clubroom.

Various considerations have to be taken into account, and general support must be promptly obtained. For this purpose it is suggested:

1. That the Executive Committee invite interested members to confer with them on the subject, putting a general notice in "Fabian News," but specifically inviting by individual notice all the members of the Executives of the Women's Group, the Nursery, the Summer School Committee, the Research Department, the Social Committee and the Subject Groups, together with the Executive of the Universities Socialist Federation, the Secretaries of University and Local Societies, and of London Groups.

The following memorandum might be submitted to such a meeting.

It is suggested that (a) it is inadvisable to allocate any of the Society's funds to purposes of a social character, in which only a minority of the membership can practically share: (b) that the Executive should be relieved of Club management: and, (c) that it is desirable to widen the opportunities for taking part in Fabian administration.

For these reasons, it seems -

2. That the proposed Fabian Clubroom should have its own finances, and be under the management of its own Committee (subject to the supreme control of the Executive); and should bear its share of the repairs, rent, taxes, telephone, caretaking, cleaning, heating and lighting of 25 Tothill Street (preferably by an agreed annual payment).

There would be many advantages in opening the Clubroom, without extra payment, to all Fabian members. In view, however, of the foregoing considerations, this seems impracticable. The members of the University ~~Socialist~~ Societies pay us only 1/- a year. A very large number of other members pay only 5/- or 10/- a year subscription. Many thus fail to repay the out of pocket cost that their membership entails, let alone contribute towards standing charges. The financial position of the Society is, indeed, gravely jeopardised by having taken expensive new offices at a moment when its income

CDA

(like that of all other Societies) is seriously falling off owing to the War. It seems therefore inevitable that there must be some special payment for the Clubrooms, which the Executive Committee would otherwise have to sublet, in order to help towards the rent. We might conceivably include the use of the Clubrooms in the ordinary subscription; but it would then almost be necessary to restrict this privilege to members paying to the Society not less subscription than a guinea a year.

It seems on the whole preferable:

3. That membership of the proposed Fabian Clubrooms should be confined to those paying a separate Club subscription but this should be fixed at as low a rate as possible.

The rental value of the two rooms proposed to be assigned for this purpose seems to be £70 a year (the amount agreed for similar rooms occupied by the Research Department). To this must be added the cost of cleaning, lighting, heating, and also for additions to and maintenance of furniture (practically the whole of the initial cost of furnishing, it is assumed, will be provided out of donations). There will need to be newspapers and magazines, and some new books provided; and perhaps some attendance. Arrangements for the latter may, however, be met by profits on teas supplied. It seems:

4. That it is necessary to provide an income for the Clubroom of at least £100 a year, and preferably £125 or £150.

The question then arises at what sum the Club subscription should be put. Can we undertake, from the start, to get 250 members at 10/- a year? It seems clear that we cannot reckon on 500 at 5/- a year. Unless we can straight-way enrol 250 at 10/-, it is suggested that we should have to make the subscription a guinea a year: or abandon the project.

It seems therefore:

5. That the subscription should be fixed at 10/- a year, for town and country members alike; that donations should be invited for a Book and Newspaper Fund, so that the Clubrooms may be well equipped with all Socialist publications and a certain supply of interesting new books;

that efforts should be made to begin with an enrolment of 250 members; that those present should be urged at once to give in their names, and personally, to canvass their friends among Fabians, so that the required number be promptly made up.

It has been suggested that recruiting would be assisted if membership were made a privilege; and that it would be advisable with this view to limit the number of members to 250 in the first instance, as Original Members. Subsequent members would be admitted only on the occurrence of vacancies, and subject to approval by the Club Committee (virtually, a power to veto). Opinion on this suggestion is invited.

It has also been suggested that Club members should be allowed to bring in one non-member each as visitors when they visit the Club.

The question of hours must be considered. THE FINANCIAL POSITION OF THE UNIVERSITY FABIAN
SOCIETIES WITH REGARD TO THE LONDON FABIAN SOCIETY.

The office has been instructed to Report on the financial position of the University Fabian Societies with regard to the London Fabian Society.

It has been the practice for the Executive Committee to elect all members and associates of the University Fabian Societies as full members and associates of the London Fabian Society on the understanding that the University Fabian Societies pay 1/- per annum to the London Fabian Society for each member and associate, as membership and associateship subscription. This fee is not collected by the Fabian Office from each University member and associate, the arrangement being that a sum should be paid annually by each University Fabian Society sufficient to cover all the fees due.

The present position of the various University Fabian Societies with regard to these fees is as follows:

Aberystwyth U.F.S. has paid 10/- since its formation in 1913.

Birmingham U.F.S. has paid fees up to March 31st, 1914.

Cambridge U.F.S. has not paid since 1913, when £8 15. 0. was paid for arrears. Up to March 31st, 1914, £12 was due.

Edinburgh U.F.S. has paid irregularly in odd amounts.
21/- was paid in 1914.

Glasgow U.F.S. was considerably in arrears and the Exec. Com. agreed that it should be allowed to recommence payments from last year. It now sends one shilling for every new member. Amount paid in 1914 was 26/-.

~~SUMMONED~~ REPORT TO EXECUTIVE COMMITTEE.

We have considered the ~~enclosed~~ application for the circulation to all the members of an address proposing changes in the Society's constitution and policy; and we submit it for consideration with the following comments.

The circulation of Manifestoes or addresses by members or groups of members has never yet been allowed. The grant of facilities for members to submit manifestoes to the whole Society was one of the propositions brought before a members' meeting in 1911, when it was referred, with the others, to a Special Committee. It was rejected by that Committee. The discussion was renewed at the Executive Committee, when the recommendation was rejected, only 2 voting for it.

It would therefore be in normal course for the present application to be refused, on the ground that it was undesirable, or even unfair, to accord to some members an opportunity of putting their case which could not practically be conceded to all, and which others had not been allowed.

We think, however, that - apart from the subject matter of the particular application which should be separately discussed - that the Executive may well consider whether our practice might not be altered in the direction desired. We do not think it advantageous that the Society should be necessarily asked to discuss its own constitution and policy, instead of carrying out its work for the time being: but it may well be desirable to allow opportunity for this, say once a year. It may be remembered that an amendment of the Basis cannot be moved except at the Annual Meeting. Nor would it be convenient to allow the Society's organisation to be used for the purpose of raising purely abstract questions, on which the members were not called upon to vote. We think, moreover, that this privilege ought not to be allowed in such a way as to give any particular section an advantage over others; or so as to involve the Society in expense.

We suggest for consideration that, if the Executive Committee should think it advisable to make the innovation, and allow the submission of manifestoes to the members, this

should be done on the following conditions, which should be published in FABIAN NEWS.

In response to a desire which has been expressed by various members, the Executive Committee has decided, as an experiment, to afford, to members wishing it, the following facilities for submitting to all the members of the Society any proposals which it is desired to bring before the Annual Meeting: -

1. Any document for circulation must take the form of a reasoned statement in support of definite resolutions to be moved at the Annual Meeting, formal notice of those resolutions being given at the same time. If the resolutions aim at alteration of the Rules or Basis, they should be drafted with precision so as to permit of incorporation without verbal change in the constitution as printed.
2. The document must be free from personalities and from denunciation of any group or section, within the Society or without; and must not exceed in length words.
3. The document, together with notice of the resolutions which it is proposed to move, must be received in the office before the 23rd of February. In order to permit opportunity for notice to be given of amendments, it will normally be issued with FABIAN NEWS for April.
4. It will be open for any member to give notice before 23rd of April of any amendments which it is desired to place upon the notice paper for the Annual Meeting. Any member may submit for circulation with FABIAN NEWS for May, a reply or counter statement on the same subject, either in support of such amendment, or merely in support of the negative. Such a reply or counter statement must not exceed in length words.
5. The Executive Committee will, if they think fit, report to the members upon the resolution or amendments of which notice has been given, and make any comments that they consider necessary upon any statement or counter-statement, either in the same issue of FABIAN NEWS, or subsequently.
6. No expense must be thrown on the Society's funds by the circulation of any statement or counter statement, and accordingly the sum of which is calculated as just equivalent to the extra cost of printing, etc. must be paid when the document is handed in. If owing to several documents having to be simultaneously circulated extra postage is involved, the amount must be shared and refunded.


