THE object of the Association is the independent, non-partisan cultivation of "such public opinion as will induce the National Administration to enter the League of Nations at the earliest possible date on such terms as to such Administration may seem wise," provided only that the terms are consistent with the Constitution and consonant with the dignity and honor of the country.

S EVEN years ago the League of Nations began at Geneva its endeavor to "promote international co-operation and to achieve international peace and security."

Four years ago the League of Nations Non-Partisan Association was formed. It is an American organization, open to all Americans. It is chartered as a membership association, empowered to hold public meetings, conduct lecture and speaking tours and to engage in educational work, to the end that American citizens may be fully informed on League of Nations work and that they may realize the value of membership in the League.

The United States can become a member of the League only when the Government has officially adhered to the Covenant. Pending such action, the United States cannot participate in the meetings of the Council or the Assembly of the League. **THE UNITED STATES WILL JOIN THE LEAGUE ONLY WHEN THE MASS OF THE PEOPLE SHOW THE GOVERNMENT AT WASHINGTON THAT THEY BELIEVE WE SHOULD TAKE OUR FULL PART IN ITS DELIBERATIONS.**

In the meantime, the Administration is participating more and more in all phases of League of Nations activities,

officially and unofficially. The League has called an Economic Conference for May, 1927. *The United States will send representatives.* For the past two years, the League has been working intensively on the problem of armament reduction. **American experts have attended all sessions.** The League is engaged in social and humanitarian enterprises and in bettering working conditions throughout the world. **Americans are actively participating in this work.**

The League of Nations Non-Partisan Association is composed of thousands of American men and women voters who believe the United States should participate in ALL League work. That means full membership, with a seat in the Council—which has been waiting for us since 1920—and a vote in the Assembly. **UNTIL THE UNITED STATES DOES THIS, THE FULL POTENTIALITIES OF THE LEAGUE FOR WORLD PEACE, SO DESIRED BY THE AMERICAN PEOPLE, WILL NOT BE REALIZED.**

What Membership in the League of Nations Non-Partisan Association Means

Each member of the League of Nations Non-Partisan Association has certain privileges and certain obligations.

THE PRIVILEGES

Each class of membership entitles the member to participate in local, state and national activities of the Association. Each class entitles a member to call on the Association for assistance from the major services which it maintains. These services are:

1. **AN EDUCATIONAL DEPARTMENT** which is conducting a campaign of information on the League of Nations, the World Court and the International Labor Office. The department is equipped to furnish factual material to schools, libraries, churches, women's clubs, civic organizations and all groups interested in the general subject of international cooperation. This material is available in the form of a manual for teachers, reference hand books, individually prepared study courses and a monthly clip sheet or news letter "Round the World with the League of Nations." It specializes in the preparation of programs of work on international relations from the viewpoint variously of business men, bankers,

labor organizations, women's clubs and study groups which have chosen special phases of current history. These programs give fully detailed topics for discussion with copious reference material.

2. **A LIBRARY** of information on the League of Nations, the World Court, the International Labor Office and allied subjects. This library service is built upon a foundation of League of Nations documents—full proceedings of the Council and the Assembly, research data issued by the Secretariat, reports of special commissions on political, financial, economic, health and social problems. In addition, it has a complete collection of current works of comment, history and general reference.

3. **AN INFORMATION BUREAU**—for the distribution of short, authoritative literature on many phases of international cooperation.

4. **A SPEAKERS' BUREAU** — through which speakers on international subjects may be secured.

5. **THE LEAGUE OF NATIONS NEWS**—a monthly magazine devoted to world events and especially League of Nations, World Court and International Labor Office news. Subscription Price, \$1.00 per year.

6. **A PUBLICITY DEPARTMENT** engaged in dispensing authentic information on world affairs through the medium of newspapers and periodicals.

7. **A MOTION PICTURE** which is ready to be shown in schools, churches and clubs to stimulate interest in the League of Nations as the sane and practical means of arriving at international understanding.

8. **STEREOPTICON SLIDES** of the League of Nations at work and charts for conventions and school room study, giving short and graphic pictures of the organization and activities of the League.

THE OBLIGATIONS

The only obligations of membership in the League of Nations Non-Partisan Association are that the members shall consider themselves as representatives of the awakened consciousness of the United States so far as international cooperation is

concerned; that they shall consider themselves agents of the Association in the dissemination of all facts which come to them through the channels of the organization; that they shall permit no falsehood con-

cerning the League of Nations to go unchallenged and that they shall strive day in and day out to show to their fellow citizens the moral duty of the United States to join the League of Nations at Geneva.
