My application to Newnham was  
very simple -

I send you the Boston people's letter from which you will see they neither bless it at all or curse it at all - I have not committed myself in any way to this point but I wish to enquire from the powers that be whether such an arrangement would be possible. ## NEWNHAM COLLEGE SCHOLARSHIPS.

### Scholarships for 1890—91.

The Council of Newnham College offer the following Scholarships for competition in the Cambridge Higher Local Examination to be held in June, 1890 :—

(a) One of £50 for three years, founded by the late Mr. Stephen Winkworth, called the Winkworth Scholarship.

(b) One of £50 a year for two years, given by the Goldsmiths' Company.

(c) One of £50 a year, for two years, given by the Clothworkers' Company, to be held by a student whose resources are inadequate to defray the expenses of residence at Newnham College.

(d) One of £50 a year, for two years, given by the Drapers' Company, to be held by a Student who is preparing for the profession of teaching.

These four Scholarships will be awarded either (1) for success in two of the groups, A, B, C, D, E, H, provided that one at least of the two be B or C; or (2) for distinguished performance in two languages of group B, (of which one must be Latin or Greek), or, in group C, or, in the case of Students not yet in residence, in group E.

(e) One of £50 a year, for two years, called the Cobden Scholarship, given by Mrs. Stephen Winkworth, to be awarded either (1) for distinguishing success in Group D, including distinction in Political economy, or (2) for distinguished success in Group H, together with distinction in Political Economy.

(f) In addition to the above, one or more Scholarships of £35 for one year, will be awarded to candidates who have not gained one of the larger Scholarships.

The Scholarships of £35 may sometimes be awarded for distinguished success in the Higher Local Examination in December.

The Council of Newnham College offer for competition in the Cambridge Senior Local Examination to be held in December, 1890 :—

The Stevenson Scholarship of £35 for one year.

The Scholarships offered in the Higher Local Examination in any year will be awarded only to Students who have either (1) passed in two Groups of the Higher Local Examination, one of these being B or C: or (2) gained Honours in the Senior Local Examination and passed in either Group B or Group C of the Higher Local Examination; and they will not, generally speaking, be awarded to candidates who have already resided as Students for two or more terms, unless they have fulfilled the conditions as to examinations required by the University before admission to a Tripos examination. In all cases the performance, if any, in preceding years, will be taken into account in awarding the Scholarship.

Candidates for any of the Scholarships offered in the Cambridge Higher Local Examinations are requested to give their names and addresses to the Local Secretary of their centre during the week of the examination.

### NEWNHAM COLLEGE EXAMINATIONS.

(1). There will be an Annual Examination in Classics held at Newnham College in March, the first to be in 1890.

(2). The Examination will be open to Students of Newnham College in their first year of residence, and to women desiring to enter the College.

(3). There will be five papers set, as below :

(4). A Scholarship of £50 for one year will be awarded to the best candidate, provided that such candidate attains a standard satisfactory to the Examiners.

(5). Scholars and any other Candidates recommended by the Examiners will be admitted to the College without any further qualifying examination.

Candidates must send their names, and pay the fee of two guineas, to Miss Gladstone, Newnham College, not later than ( *March 1* ).

(1). There will be an Annual College Examination in Natural Science held in June, beginning in 1891, for Students of Newnham College who have resided for not more than four terms.

(2). The Examination will include the following subjects :—

(a) Chemistry; (b) Physics; (c) Biology; (d) Geology; with practical work in each subject.

No candidate will be allowed to take more than three subjects. The practical work in any subject taken will be compulsory.

### Scholarships for 1891—92.

The Council of Newnham College offer the following Scholarships for competition during the year 1891—92 :

(a) One of £50 for three years, founded by the late Mr. Stephen Winkworth, called the Winkworth Scholarship.

(b) One of £50 a year, for two years, given by the Goldsmiths' Company.

(c) One of £50 a year, for two years, given by the Clothworkers' Company, to be held by a Student whose resources are inadequate to defray the expenses of residence at Newnham College.

(d) One of £50 a year, for two years, given by the Drapers' Company, to be held by a Student who is preparing for the profession of teaching.

(e) One of £50 a year, for two years, called the Cobden Scholarship, given by Mrs. Stephen Winkworth.

(f) One of £50 a year for one year.

(g) The Birmingham Scholarship of £35 for one year.

(h) One or more of £35 for one year.

At the Classical Scholarship Examination to be held at Newnham College in March, 1891, a Scholarship of £50 a year, for three or two years will be awarded to the best candidate, provided that such candidate attains a standard satisfactory to the Examiners.

At the Natural Sciences Scholarship Examination to be held at Newnham College in June, 1891, a Scholarship of £50 a year for two years will be awarded to the best candidate, provided that such candidate attains a standard satisfactory to the Examiners.

At the Natural Sciences Examination for Higher Certificates to be held by the Oxford and Cambridge Joint Board in July, 1891, a Scholarship of £50 for one year will be awarded to the best candidate, provided that such candidate attains a standard satisfactory to the Examiners.

In all the above Examinations, if no candidates of sufficient merit present themselves, the Scholarships may be diminished in value, or withheld.

At the Cambridge Higher Local Examination to be held in June, 1891, the following Scholarships are offered :

Two Scholarships at least of £50 a year, for two or three years, will be awarded either (1) for distinguished success in Group C; or (2) for success in two of the Groups A, B, C, D, E, H, provided that one of the two be B or C.

The Cobden Scholarship will be awarded either (1) for distinguished success in Group D, including distinction in Political Economy, or (2) for distinguished success in Group H, together with distinction in Political Economy.

One or more smaller Scholarships of £35 may be awarded to candidates who have failed to obtain one of the larger Scholarships.

One of the Scholarships of £35 may be awarded for distinguished success in the Cambridge Higher Local Examination to be held in December, 1891.

The Birmingham Scholarship will be awarded for distinguished success in the Cambridge Senior Local Examination held in December, 1891.

Generally speaking, no Scholarship tenable for three years will be awarded to a Student who has resided for two or more terms at Newnham College, and no Scholarship tenable for two years will be awarded to a Student who has resided for five or more terms at Newnham College.

All Scholarships will be continued to Students for a second, or for a second and a third year, if their circumstances make it important to them, provided that they are doing sufficiently advanced work and are making satisfactory progress.

Scholars are required to reside during the term for which they hold their Scholarships; they must begin residence in the October following their election, unless they have not then attained the age of 19, or unless they are prevented by grave cause to be approved by the Council. Permission to defer residence will under no circumstances be granted for more than a year; and a Scholarship will only be awarded if the Council is satisfied that the candidate's state of health is not such as to prevent her from profiting by a systematic course of study at Cambridge.

No two of the above Scholarships can be held simultaneously by the same person. Nor can any of them be held with the Gilchrist Scholarship.

The Council award some Scholarships otherwise than by the above Examinations to Students who have begun residence and whose circumstances make it important to them. Information about all Scholarships will be given by Miss Gladstone.

A certain number of Exhibitions of five guineas a term are awarded to Students resident in the College needing assistance, regard being had to intellectual qualifications, and a written statement of circumstances being required. The Tripos fees of these Exhibitors may be paid by the College on the recommendation of the Principal or the Vice-Principal.

Exhibitions are tenable with Scholarships.

#### Loan Fund.

There is a Loan fund at the disposal of the College, from which Students of limited means may obtain help towards the payments of their fees. They will be expected to give adequate testimony respecting their intellectual qualifications, and to make a statement of their circumstances.
