EASTERN COUNTIES FEDERATION.

RULES.

1. NAME.—The name of the Federation shall be the EASTERN COUNTIES FEDERATION of the N.U.W.S.S.

2. AREA.—The area of the Federation shall include the counties of Cambridgeshire, Norfolk, Suffolk, Huntingdonshire, Essex (except the Parliamentary divisions of Romford and Walthamstow), Hertfordshire (except the Parliamentary division of W. Herts.), and the Spalding division of Lincolnshire, together with the borough of Boston.

- 3. OBJECT.—The object of the Federation is :--
- (a) To promote the formation of new Societies in its area.
- (b) To perfect existing organisation.
- (c) To arrange joint meetings, and generally to secure cooperation among Societies in its area.

4. COMMITTEE.—The Committee shall consist of members of the Executive Committee of the N.U.W.S.S. and of representatives of all Women's Suffrage Societies contained within the Federation area and affiliated to the N.U.W.S.S.

- (a) Every member of the Executive Committee of the N.U.W.S.S. who belongs to any Society within the Federation shall be ex officio a member of the Federation Committee.
- Societies within the Federation on the following basis :---Societies with from 20-100 members shall be entitled to one representative. Societies with from 100-200 members shall be entitled to two representatives. Societies with over 200 members shall be entitled to three representatives.
- (c) Representative members shall be appointed for one year. If a representative is prevented from attending a meeting, the Committee of the Society she represents may choose a proxy to attend the meeting, the name of the proxy being sent to the Hon. Sec. of the Federation beforehand.

(b) The representative members shall be chosen by the

EASTERN COUNTIES FEDERATION.

January 1st to December 31st, 1912.

During the past year it has become increasingly clear that there is a real demand for Women's Suffrage in the Eastern Counties, and this demand becomes deeper and more insistent as ignorance and misunderstanding on the subject are removed. The Federation has made a special effort to do educational work in country districts, and has met with considerable success; the only discouraging element has been the fact that in many cases the enlightenment of Members of Parliament has not kept pace with that of their constituents.

NEW SOCIETIES.

The number of Societies grew during the year from 19 to 41, but this total has been reduced recently to 32, by the transference of the county of Bedfordshire, with 5 branches, to the Oxford, Bucks., and Berks. Federation; by the unfortunate disorganisation of the branches at Dunmow and Wisbech, owing to the illness or removal of the Secretaries; and by the fact that the organisations at Spalding and Stowmarket are not yet complete. New Societies were formed at the following places :- Aldeburgh, Boston, E. Cambs., W. Cambs., Cromer, Fakenham, Felixstowe, Harwich, Hunstanton, St. Albans, Sheringham, Southend, Spalding, Thetford, and Yarmouth. The following Societies already in existence joined the Federation :---Cambridge University Women's (Newnham and Girton), King's Lynn, Lowestoft, Luton, March. The Bury and Stowmarket branch divided into two Societies.

COAST CAMPAIGN AND VAN TOUR.

Fresh ground was broken in the summer by two special pieces of work undertaken by the Federation. with financial help from the National Union. During the Coast Campaign the following places were visited:-Cromer, Clacton, Walton-on-the-Naze, Frinton, Kirby Cross, Harwich, Southwold, Lowestoft, Yarmouth, and

(d) The Committee shall appoint Chairman, Hon. Secretary, and Hon. Treasurer, and such other officers as may be required. All officers to be ex officio members of Committee.

5. MEETINGS .- The ordinary meeting of the Committee shall be held three times a year, in the October, January and April quarters. Unless special circumstances arise, these meetings shall be held in Cambridge.

Extraordinary meetings may be summoned at the discretion of the officers, or at the request of the representatives of any three. Societies.

6. FINANCIAL.

- (a) Each Society shall be responsible to the Federation for a certain sum per annum, the amount to be agreed upon by the Society in consultation with the Federation Treasurer.
- (b) The financial year shall begin on January 1st.
- (c) The accounts of the Federation shall be audited annually by an auditor appointed by the Committee.

7. MEMBERS. - Any persons wishing to join the N.U.W.S.S. and not being within reach of a branch, may be enrolled as Federation members, with a minimum annual subscription of 1/-.

Sheringham. The campaign owed its success almost

entirely to voluntary workers, and our special thanks are due to Mrs. Machin, Miss A. Villiers, Miss B. Morrison, Miss E. L. Willis, and other members of the Norwich Society. We have now 9 Societies on the coast.

The National Union van was hired for the month of August, and had an interesting and successful tour in N. Norfolk, in spite of almost continuous bad weather. The helpers camped at the following places: Cawston, Reepham, Foulsham, Hindolvestone, Briningham, Holt, Cley, Stiffkey, Wells, and Walsingham. At all these places meetings were held and members enlisted, and many other villages were visited on bicycles. Owing to bye-elections, we were not able to have a N.U. organiser until the middle of the month, and our warmest thanks are offered to the voluntary helpers: Misses Usher, Wright, Eckhard, Ord, Eustace Smith, and Willis, as well as to the N.U. cookcoachman, Miss Collum. After the first fortnight, the N.U. were able to send Miss Misick, Miss Clarkson, and Mrs. Streeter in succession to take charge of the tour. The distribution of literature was a great part of the work, and at almost every village the workers met with great kindness and appreciation.

ORGANISERS.

The continuity of work during the year has been much interrupted owing to our inability to raise enough money to pay the salary of an organiser, and we have had no less than nine different N.U. organisers working in the Federation at different times, apart from those specially sent for bye-election work. In July, however, we were able to appoint Miss Creak as Organising Secretary, and this appointment will, we feel sure, be of the utmost benefit to the work of the Federation.

Besides the voluntary helpers mentioned in connection with the Coast Campaign and Van Tour, we owe much to Miss Reeve, who worked in Mid-Norfolk in the midst of floods; to Miss Sugden, and to Miss Reckitt.

BUSINESS MEETINGS.

The Federation Committee has met three times during the year, once at Norwich and twice at Cambridge. It has not yet been possible to secure full representation of all the Societies at these meetings. It is doubly unfortunate that Societies should not be represented at Committee meetings, since it is impossible to carry out a system of co-operation without representation, and there is a tendency on the part of some branches to regard the Federation as a thing apart, whereas, of course, it is simply the Societies themselves. A chain is no stronger than its weakest link, and the strength of the Federation depends on the goodwill and loyalty of the smallest Society.

In addition to Committee meetings, a Conference was held at Cambridge on July 23rd, in order to discuss organisation in general, and Parliamentary work in particular, with Miss Courtney, the Hon. Secretary of the National Union.

The Provincial Council was held this year for the first time within the Federation area. The Ipswich Society very kindly consented to have it, at short notice, and made excellent arrangements for both meetings and hospitality.

MEETINGS have been held in at least 134 different places in the Federation area within the year, and in some towns a large number have been organised. Norwich, for instance, held no less than 146 indoor meetings alone. Lady Frances Balfour, accompanied by Miss Eva Ward, gave two days to a Federation Tour, and spoke at Felixstowe, Harwich, Thetford, and St. Ives. Miss Helen Fraser, too, spoke at Biggleswade, St. Ives and Cambridge. We hope to arrange more such tours in 1913, as securing well-known speakers is one of the chief difficulties of smaller branches. We would draw attention to the Speakers' List on p. 36, which has been considerably enlarged since our last Report, and urge Societies to make more use of it. To those speakers on our list for 1912 who have fulfilled so many claims on them in different parts of the Federation area, our heartiest thanks are offered.

FEDERATION MEMBERS have increased in number, and during 1913 we shall hope to consolidate the different groups into small Societies, which might well be formed in the Sudbury division of Suffolk, in N. Norfolk, in the Dengie Hundred (Essex), and in Mid-

Most of these gentlemen professed to vote as they did as a protest against militant tactics, though it was clearly pointed out to them that they were playing into the hands of the militants by destroying a bill backed solely by constitutional Suffragists.

The Committee on Oct. 22nd passed an urgent resolution begging Members of Parliament for con-stituencies in the Eastern Counties to vote in support of Mr. Philip Snowden's amendment to the Home Rule Bill.

Copies of this resolution were sent to all the Party Whips, and to all Party Agents and M.P.'s within the Federation area.

Since the above was written, the Federation Committee has met again and expressed the strongest indignation at the failure of the Government to redeem its pledge that the Reform Bill should be so drafted as to be capable of amendments to include women.]

MEMORIALS.

Miss Thompson, organiser of the West Lancs., West Cheshire, and N. Wales Federation, whose success in memorial work has been so marked, was engaged for two of our divisions, S.E. Essex and S. Beds. In both cases she organised very influential memorials, which effectually showed that both the Hon. Rupert Guinness (U.), and Mr. Cecil Harmsworth (L.), were mistaken in declaring that there was no demand for the suffrage

Norfolk. There now remain 6 Parliamentary divisions in our area in which no branch of the National Union exists, and though this number is small compared with the 18 of our last Report, yet we cannot rest until we have eliminated it altogether.

ACTIVITIES OF SOCIETIES.

The following Societies are working the "Friends of Suffrage" scheme: Cambridge, E. Cambs., W. Cambs., Colchester, East Herts., Hitchin, Hockwold, Ipswich, Letchworth. We trust that many more will engage in this valuable work during 1913. Among other useful pieces of work undertaken by Societies we would draw attention to a series of village meetings, Café Meetings and Speakers' Classes organised by Cambridge; to the admirable series of lectures on various topics of public interest with which women are specially concerned, arranged by Hitchin and District; to a series of meetings for women engaged in special occupations, e.g., teachers, nurses, domestic servants, etc., arranged by Norwich, and we would commend their enterprise to Societies which still have scope for further activity. Other Societies have undertaken American teas, blouse sales, cake and candy sales, sales for housewives, jumble sales, lace sales, lantern lectures, plum pudding sales, self-denial weeks, whist drives, White Elephant Fairs, etc., and particulars of the organisation of any of these ways for raising funds may be obtained from the Hon. Secretary.

PARLIAMENTARY.

We cannot help regarding it as unfortunate that we have been obliged to spend so much time, energy, and money on bringing pressure to bear on Members of Parliament with so little apparent result. On March 28th, 15 M.P.s voted or paired for the Conciliation Bill, 20 voted or paired against, and 6 abstained (see list on p. 35). The following lists are instructive:

During the year deputations have waited on the following M.P.'s: Sir E. Beauchamp, Mr. Cecil Beck, Mr. Noel Buxton, Mr. Fell, Hon. W. Guinness, Hon. R. Guinness, Mr. Cecil Harmsworth, Mr. Kellaway, Mr. Locker Lampson, Col. Lockwood, Sir F. Low, Mr. Newton, Mr. Paget, Capt. Peel, Sir R. J. Price, Hon. Neil Primrose, Mr. Rawlinson (Cambridge Univ. Men's League), Mr. Roberts, Mr. Worthington-Evans.

Half-a-dozen M.P.s refused for various reasons to see deputations, and the remaining Members have all been approached either personally or by letter or post cards, with urgent requests to support Women's Suffrage.

BYE-ELECTION.

The bye-election in N.W. Norfolk in May was organised by the National Union, and much useful work was done in connection with it. It resulted in the return of Mr. Hemmerde (L.), who has promised to give his best support to our cause in Parliament.

PRESS WORK.

During the year Miss Fanny Johnson was obliged on grounds of health to resign the post of Press Secretary, and it was felt that, as no successor could be found, the time had come to re-organise the Press work of the Federation. There are nearly 150 newspapers published within our area, and this is, of course, far too large a number for one person to be responsible for, even after deducting those with which local Societies are in touch. We are now trying to appoint a Press Secretary for each county, and hope to have the new scheme in working order early in the new year.

Meanwhile, we are able to report that the following newspapers are willing to insert Suffrage news and give good reports of meetings:—

"Cambridge Daily News," "Cambridge Independent Press," "Citizen" (Letchworth), "East Anglian Daily Times," "Eastern Daily Press," "Essex County Chronicle, Herald and Newsman," "Essex County Standard," "Essex Weekly News and Independent," "Herts. Express," "Herts. Mercury," "Hunts. County News," "Hunts. Post," "Lowestoft Journal," "Lowestoft Weekly Press," "North Herts. Mail," "St. Neots Advertiser," "Southend Standard," "Southend and Westcliff Graphic," "Yarmouth Mercury."

In most cases, Suffrage news is more willingly accepted if it has a local flavour, and personal paragraphs, with portraits of speakers, are usually preferred to columns of reasoned arguments. This is, of course, natural, and we would urge Societies to lose no opportunity of making public whatever work they do, and whatever progress they are able to record.

FINANCIAL REPORT FOR 1912.

On January 1st, 1912, the Federation had a cash balance of $\pounds 60$ 5s. 4d. Our total income during the year has amounted to $\pounds 311$ 14s. We have spent $\pounds 341$ 19s. 2d. as against $\pounds 125$ 7s. 5d. last year, and reduced our balance at the Bank to half the sum with which we began the year, viz., to $\pounds 30$ 0s. 2d.

 $\pounds 6$ 19s. 6d. of our expenditure this year was incurred during 1911. Our outstanding liabilities on January 1st, 1913, amounted to $\pounds 17$ 5s. 6d.

The note of the year has been growth. The number of the Societies has increased from 19 in January, 1912, to 32 in January, 1913. Our income has more than doubled, and our expenditure has kept pace. We have paid $\pounds 224$ 3s. 2d. to Organisers as against $\pounds 108$ 9s. 6d. in 1911; we have doubled our expenditure on Secretarial and Office expenses, and more than doubled our payments for literature. We have financed public meetings,

to be the consolidation and strengthening of our existing Societies, and a greater measure of co-operation between us all. Our scheme of work and of expenditure should keep these ends in view.

and a van tour for purposes of propaganda, and during the year we have undertaken the responsibility of maintaining an Organising Secretary for the Federation.

The lists which follow this Report make it clear that it is the generosity of a few both among Societies and individuals that has made this growth and activity possible. The name of Mrs. Rackham, our Chairman, should be mentioned with gratitude in this connection.

Progress can only be maintained if a far greater number realise the responsibilities resting upon the Federation of which they are members.

A Finance Sub-Committee was formed in January, 1912. This Committee issued three special appeals during the year:—

- (a) An appeal to men bringing in $\pounds 25$ 13s. 6d.
- (b) An appeal for a million farthings, bringing in to date £5 2s. 4d.
- (c) An appeal to the Societies to organise sales and entertainments; this brought in £38 17s. 9d.

At the Committee meeting held in October, in Cambridge, it was decided to remit all Federation fees for the future. Apparently these fees had been an obstacle to the realisation by some Societies of their share in the financial responsibilities of the Federation. These Societies did not understand that any further obligation rested upon them after the fees had been paid. The removal of this misunderstanding will, we hope, result in a larger income for the Federation.

It should be noted that certain expenses which should properly have been borne by the Federation were paid by individuals, and to these we offer our heartiest thanks. We would also add our thanks to Mrs. Rackham for the cyclostyle, and to Mr. Kellett for the typewriter, which have been lent to the Federation since its beginning, and which have saved much expense.

It is unfortunate that a two-fold change of Treasurership should have coincided with a year of such rapid growth. To this (in my judgment) may be attributed a certain lack of co-ordination between the financial and the executive side of the work of the Federation. The need for the coming year seems to me

Since the separation of the Bury and Stowmarket groups of members, the Bury membership is 29.

In May last a well-attended meeting was held at the Athæneum, at which Lady Frances Balfour and Miss Eva Ward spoke On Nov. 2nd an influential deputation interviewed our Member, Mr. Walter Guinness, M.P., and urged him not to vote against the Snowden Amend-ment to the Home Rule Bill, even if he would not vote for it. He said he was opposed to Woman Suffrage, but if

he was convinced that the majority of women wanted it, he would have no right to refuse it them. He quoted figures as to municipal voting by women in a poor East End district he once sat for, but when the figures of the last Municipal Election in London were quoted to him, he declared that figures were invariably misleading.

The local Press refuses to take any Suffrage news other than purely local and personal matter,

CAMBRIDGE.

The year 1912 has been one of exceptional activity on the part of our Society, propaganda work of many kinds having been vigorously carried on both in the Borough and County. As a result of work in the County two new Societies, "East Cambridgeshire" and "West Cambridgeshire" have recently been formed; to assist in their formation the good services of Miss Bagenal, as Organiser, were engaged by the Association for three weeks. Even outside the County, in Norfolk, Huntingdonshire, and Suffolk, missionary work has been undertaken. At the same time, considerable contributions to the funds of the E.C. Federation have been directly made.

During the year the Committee, consisting of twenty members, has met twenty-two times; and three General Meetings of members of the Association have been held. On one occasion, Miss O'Malley gave an address upon the Friends of Women's Suffrage scheme, and it is now being actively promoted in Cambridge; we have fifteen Visitors and over 300 Friends.

On Oct. 22 a large and very successful meeting was held in the Guildhall to consider especially the Moral and Social Aspects of Women's Suffrage. The Rev. the Master of Selwyn took the chair; the speakers were the Very Rev. the Dean of Worcester, Mrs. Osler, the Rev. R. H. Strachan, Professor Bethune-Baker, Professor Sims Woodhead, and Mrs. Rackham.

Early in the year various Sub-Committees were formed for special departments of work, such as the distribution of literature in public places and at the entrances of Halls, etc., where meetings of various kinds were being held, the establishment of a "Pass-it-on" library, the formation of a Speakers' Class, the arrangement of Private Drawing-room and Garden Meetings and At Homes; and, in particular, the organisation of Open-air and other Public Meetings in the

During April, May and June four evening At Homes were held in the Oriental Café, addresses, followed by discussion, being given on such subjects as Votes and Wages, the Social Evil, Local Government. During the Long Vaca-tion five Open-air Meetings were held in the Market Place; these were attended by orderly crowds of from 300 to 500 men and women. During the visit to Cambridge in August and September of the Extension Students four afternoon At Homes were held in the Downing Street Assembly Room, especially for them; tea was provided, various addresses were given, and much literature distributed and sold.

In the County many meetings were held: at Newmarket, Burwell, Waterbeach, Melbourn, Swavesey, Stretham, Hartingfield, Foxton, Harston, Little Shelford, Abingdon, Linton, Duxford, Icleton, Soham, Cherryhinton, Fen Ditton, and Sawston.

In addition to meetings organised solely by the Association, conferences and discussions have been promoted in connection with various Clubs and Societies, political or other: notably, one on Nov. 29th in the Co-operative Hall, with the local branches of the I.L.P., and the Fabians, Mrs. Annot Robinson being asked by us to speak.

Other important work has been the organisation of a Deputation to the Borough M.P., Mr. A. Paget, on Feb. 16th, and of a Voters' Memorial to him re the Franchise Bill, in December. Some pressure was also brought to bear on the Representatives of the University, Mr. Rawlinson and Sir Joseph Larmor; and from time to time correspondence has been carried on with the more friendly Representatives, Sir Charles Rose and the Hon. E. S. Montagu, the immediate interests of women in connection with various Parliamentary events being pressed upon their notice.

Much useful propaganda has also been carried on through the medium of the local papers, Miss F. Johnson ably conducting the work as Local Press Secretary

Our largest meeting of the year was the 'At Home' given by the generosity of Mrs. Hatcher in the Shire Hall on March 21st. Our President, Lady Rayleigh, took the chair, and the Grand Jury Room was crowded to hear Mrs. Alderton and Sir John Cockburn, K.C.M.G., who made stirring speeches, which were enjoyed by a representative audience of the town and neighbourhood. This Society has held seven Public Meetings in Hertford, Ware, and the adjoining villages during the past year. The chief of these was a Mass Meeting in the Corn Exchange, Hertford, in November, at which Sir John Rolleston, M.P. for the Division, took the chair, and Lord Lytton and Mr. W. H. Dickinson spoke.

In June a combined Garden Meeting and Sale in aid of the funds was held at Hertford, admission being by invitation, and the first Annual Meeting of the Society was held in Hertford in October.

There is still a large part of the Society's area which is as yet untouched. In the South, no work has been done in the large villages of Waltham Cross, Cheshunt and Broxbourne, and although we have four members in Bishops Stortford, in the East, there is no organised support there. We are in hopes that, during the coming year, with the help of the Federation, a separate Society may be formed for Bishops Stortford and the surrounding district.

The Society is still without a President, and although in many ways work in East Herts. is very encouraging, support for Women's Suffrage amongst the more influential people may almost be said to be nonexistent.

The record of Meetings held by our Society during the past year does not compare favourably with those held during 1911. This, however, must not be taken to imply any falling off in zeal on our part, but is entirely due to the fact of our having had a Bye-Election the previous year, which not only swelled our list of meetings, but also resulted in the return to Parliament of Lord Robert Cecil as Member for the Hitchin Division of Hertfordshire, and made us feel that being represented by so staunch a Suffragist ourselves, we ought to extend a helping hand to other constituencies, which were less fortunate than we were.

With this end in view, our Organising Secretary has been spending some time in other parts of the Federation area, and has been able to form three new Societies, which though small at present, will in time, it is hoped, increase in membership and vigor.

Our members have responded liberally to the many claims made on their time and money during the past critical year. In February last, we were able, through their generosity, to send £10 to the special collection made at the first Albert Hall meeting, and in November a further $\pounds 10$ for the E.F.F. which was collected at the second big meeting held last year.

A very gratifying sign of growth is seen in the response which we have met with in connection with the Friends of W.S. Scheme, although at present we are

only at the beginning of this, owing to the pressure of other work. In Stevenage, particularly, the results are most encouraging, as by far the larger number of "Friends' have been obtained by working women themselves. There appears to be practically no opposition to Women's Enfranchisement among the workers here. It is the upper and middle classes who still remain obdurate.

Our funds have been largely helped by a Cake and Candy Sale, and a Rummage Sale, which have been held. Though we have lost several members (chiefly by removal) our membership has increased, particularly in Knebworth.

Our principal Speakers during the year were: Mrs. Bonwick, Mrs. Nott-Bower, Mrs. Cooper, Miss Hessel, Miss Bertha Mason, Mr. Laurence Housman, and our President, the Earl of Lytton.

Very influentially signed memorials, worked up by

Miss Farnell with the help of Miss Staley and Miss Fordham, were afterwards presented, to Mr. Locker Lampson by Mr. H. Copley, and to Mr. Cator by Mr. Jones, J.P., urging them to support the amendment to the Reform Bill for the enfranchisement of women householders.

A Jumble Sale was held by Miss Staley at Hemmingford Abbots in September, which produced £3 8s. 6d.

The receipts from October, 1911, to December 31st, 1912, amounted to $\pounds 21$ 15s. 10d., including sales of literature.
